- (ii) East Mehram Nagar open land near, Sarvodaya School.
- (iii) Park near Sulabh Shauchalaya, Old Nangal, Delhi Cantt.
- (iv) Park in front of Chanan Singh Park Colony.
- (v) Vacant land behind Chitrakoot Guest House.
- (vi) Vacant place near 24 qtr., Sadar Bazar, Delhi Cantt.
